COMPETITORS MAY SHOOT THE FOLLOWING DISTRICT COMPETITIONS

1) SPORTER AIR RIFLE .177cal 3 POSITION (8yrs & up)

- & 2) SMALLBORE LIGHT RIFLE .22cal 3 POSITION (8yrs & up)
- **& 3)** BLACK POWDER RIFLE (11-17yrs) (Adult 18 & over) must have blackpowder shooters card
- Or SHOT GUNS / TRAP SHOOT (Any shotgun 12 gauge or smaller, may be used)

(14-15yrs) – (16-18yrs) - (Adult 18 & over) these age groups for boys & girls for trap shoot

COMPETITORS MAY USE THEIR SCORES FOR NRA POSTAL MATCHES IF THEY WISH



CALIFORNIA PENAL CODE SECTION 12551

S 12552: Furnishing Firearms to Minors under 18 without permission of parent.---Every person who furnishes any firearm, air gun, or gas-operated gun, designed to fire a bullet, pellet, or metal projectile, to any minor under the age of 18 years, without the express or implied permission of the parent or legal guardian of the minor is guilty of a misdemeanor.

DO NOT FOLLOW YOUR GPS - ENTER MEISS ROAD ONLY FROM IONE ROAD

From Highway 50 Turn RIGHT on south bound SUNRISE BLVD. Travel Approximately 7.5 miles to CA 16 East/Jackson Road TURN LEFT Travel on CA 16 East/Jackson Road for approximately 11.3 miles Turn RIGHT on IONE ROAD Travel approximately 4 miles on IONE ROAD Turn RIGHT on Meiss Road Travel approximately 0.6 miles on Meiss Road and the Shooting Club will be on your RIGHT
