District Royal Rangers is sponsoring small bore rifles "NRA 1st Steps Rifle Orientation. This is a 4-hour training course taught by NRA Certified instructors. Students will learn the NRA's rules for safe gun handlding, rifle parts and operations; ammunition; shooting fundamentals; clearning the rifes; and continued opportunities for skill

fundamentals; clearning the rifes; and continued opportunities for skill development. Students will receive the Basics of Rifle Shooting handbook, NRA Gun Safety Rules brochure, Winchester/NRA Marksmanship Qualification booklet, and a FIRST Steps Course completion certificate. In the afternoon, students will shoot the National NRA/Royal Rangers Postat Match course or fire with smallbore (.22 cal) rifles. Students will complete amongst themselves and may enter the Postal Match (with optional \$5.00 additional fee).
